

#### Grading and Condition

**Superb** Extraordinary item in the finest condition.

**Extremely Fine (XF)** A stamp or cover of outstanding and exceptional quality.

Very Fine (VF) Scott Catalog's standard. Stamps will present a nice, balanced apperance. Covers appear new or show only

minimal wear.

Fine-Very Fine (F-VF) Stamp and/or covers are sound. Stamps are fully margined but noticeably off-center. Covers show normal

travel wear

Fine (F) Sound in all aspects. Perforated stamps will have the perforations clear of the design; imperforate stamps

will not be cut into to any significant degree. Covers how extensive wear.

**Very Good (VG)** Stamps with imperfect centering, stamps or covers with poor general appearance.

#### Covers

Minor imperfections are normal for 19th-century envelopes that have been postally transmitted. These include, but are not limited to, nicks, edge or flap tears, or slight reductions; folded letters will often have at least one file fold. Further, covers may have an ordinary stamp with a minor defect. Acceptable forms of conservation include light cleaning and edge mending. These conditions, even if not described, are not grounds for return.

Unless otherwise noted, the currently available (2025 edition) Scott Catalogue values are quoted in U.S. dollars and rounded to the nearest dollar. Other catalogues are often used for foreign countries or specialized areas as required.

## **CONDITIONS OF SALE - Public Auction**

THE PLACING OF A BID SHALL CONSTITUTE ACCEPTANCE OF THESE CONDITIONS OF SALE BETWEEN BIDDER AND DANIEL F. KELLEHER AUCTIONS, LLC ("KELLEHER")

#### BIDDING

- 1. Unless announced otherwise by the auctioneer, all bids are per lot, as numbered in the printed Catalogue. Kelleher, as agent for the consignor or vendor, shall regulate the bidding and shall determine the manner in which the bidding shall be conducted. Kelleher reserves the right to withdraw any lot prior to sale (without liability to any potential purchaser or agent), to re-offer any withdrawn lot, to divide a lot or to group two or more lots belonging to the same consignor or vendor, and to refuse any bid believed not made in good faith. Estimates of sales prices contained in the printed Catalogue reflect the best judgment of Kelleher and are not minimum or upset prices.
- 2. (a) Bids shall be made in the steps set forth on the bidding page for increments. (b) The highest bid acknowledged by the auctioneer shall prevail. Should a dispute arise between bidders (including a dispute between a floor or internet bidder and the auctioneer acting on behalf of a mail bidder, consignor or vendor, the auctioneer alone shall determine who the successful bidder is and whether to reoffer the lot in dispute. Should a dispute arise after the sale, the auctioneer's sale records shall be conclusive. On all lots sold, a commission of 20% \* on the hammer price is payable by the buyer to the auctioneer together with any sales and use tax or customs duties. (c) Lots may be re-opened as necessary to accommodate connectivity issues or incorrect bids.
- 3. (a) The auctioneer reserves the right to bid on behalf of clients (and consignors or vendors) but shall not be liable for errors and omissions in executing instructions to bid, however received, and whether such errors or omissions be those of the bidder or agent or those of the auctioneer.
- (b) Lots are offered subject to a reserve price. The auctioneer will implement such reserve price by bidding on behalf of the consignor/vendor. (c) It may also be assumed that all consignors have been advanced monies against the sale of their consigned material and Kelleher therefore has a security interest in the consigned material over and above the normal auction commission.
- (d) Purchases made by a consignor or vendor or his agent on his own lots shall be considered as a sale subject to commissions and sales tax as applicable.
- (e) Agents are responsible for the payment of the purchase price for all purchases made on behalf of their clients, unless other arrangements with the auctioneer have been confirmed in writing prior to the auction.

#### PAYMENT FOR PURCHASES

- (b) Floor Bidders. Payment of the purchase price, or such part there of as Kelleher shall require, shall be made by the purchaser in cash, bank or certified check, credit card, PayPal or in such other manner as Kelleher may determine. The name and address of the purchaser of each lot shall be given to the auctioneer immediately following the sale of such lot.
- (c) Mail/Internet/FAX/Website Bidders. A successful mail bidder will be notified of lots purchased. Before Kelleher will send such lots, payment in full must be received by Kelleher within three (3) business days of receipt of the aforesaid notification by the mail bidder. However, a purchaser known to Kelleher at its option may have purchases delivered or forwarded for immediate payment (by a dollar draft, ACH or wire transfer from a U.S. bank in the case of overseas purchasers). Mailed delivery will be to the address on the bid sheet and proof by Kelleher of receipt of a sending at the advised address shall constitute delivery. This includes disputes for payments made via PayPal and/ or credit card. Buyer acknowledges that he/she waives their right to file a dispute in such cases with PayPal or their Credit Card Company. All charges for handling, delivery and insurance obtained by Kelleher on behalf of the purchaser shall be added to the purchase price; a minimum charge of \$20.00 will be made for same.
- 5. Title shall not pass to the purchaser until full payment has been received by Kelleher as agents for the consignor or vendor.
- 6. (a) Purchasers agree to pay for lots as specified in Condition of Sale 4 (or as the same may be modified by Condition of Sale 8), and no credit is extended; a late payment charge of 2% per month or fraction thereof shall be added if payment is not made in accordance with the aforesaid conditions.
- (b) In the event that a bidder shall fail to comply with these Conditions of Sale ("Non-Complying Bidder"), then, as to any lot with respect to which such failure to comply occurs, Kelleher, may, in its sole discretion, re-offer such lot during the same auction or at an auction at a later time, or by private treaty sale at such time as Kelleher Auctions, in its sole discretion, deems appropriate and the Non-Complying Bidder shall be liable for the deficiency, if any, between the hammer price and the net proceeds of a sale to a subsequent purchaser, whether at auction or by private treaty, as well as for all costs and expenses of both sales, including all other charges due thereunder, including commissions with respect to both sales, whether payable to Kelleher or to a third party and all incidental damages. - (b) Each lot is sold as genuine and correctly described, based on individual description as modified by any specific notations in this Catalogue or as announced at the time of sale.
- (c) Quality. Any lot which a purchaser considers to be incorrectly described and was not examined by the bidder or his agent prior to the sale, may be returned to Kelleher within two weeks of its receipt by such purchaser ("Returning Purchaser"), provided, however, that the same is received by Kelleher within four weeks of the date of the auction and in its original packaging; however, Kelleher may, in its discretion, refuse acceptance of such returned lot. If an opinion of a mutually acceptable authority is desired (Extension), the period of time within which a lot must be received by Kelleher will be extended in accordance with Condition of Sale 7(g). # **Featured Biography**

#### Laurence Peterson

Larry Peterson began collecting stamps in his early teens and has remained an avid collector ever since. He remembers riding his bike to the stamp store in town to acquire prized additions to his collection, saving monies earned to fill the next space. Funds were tight, and often he wouldn't add anything to the album for many months. He was always pleased to receive a special stamp or two as a Christmas gift, which became a family tradition.

All his life, he looked for U.S. issues to fill out his collection, starting with cancelled stamps, saved off of the mail, and later moving up to uncanceled issues when available.

In 1975, this boyhood pastime was rejuvenated as he came back to a hobby that had been set aside to focus on a job and his family. Starting with the year sets from the Post office as issued he spent countless hours of enjoyment filling in the pages of his album. Stamp collecting followed him all his life and in the late 1990s and early 2000s he decided he would begin collecting every United States stamp—quite an endeavor! Now crossing over to a serious philatelist, Larry was introduced to Bob Prager, who assisted him with his quest, adding as much as he could as often as he could. As with many collectors, Larry loved sharing his passion with his children and their children.

His personal favorite is the Position 1 #C3a, which is shown on the front cover of the catalog. This catalog and, more importantly, the stamps contained within, are evidence of his long-time love of stamps and collecting, and he hopes to pass his joy of collecting on to you.

## UNITED STATES 1847 ISSUE

**1847, 5¢ red brown (Scott 1),** large margins all around, rich color, 2 tiny scissors-cuts in margin and expertly repaired as in invisible to the naked eye, unused without gum, handsome Very Fine appearance, ex-Fekete, with 1985 P.F. certificate. Scott \$2,100. Estimate \$1,000 - 1,500

1847, 10¢ black (Scott 2), ample to full margins all around, lovely charcoal color, small corner crease at bottom left and small tear at bottom, both of which are invisible to the naked eye, unused without gum, handsome Very Fine appearance, an unused 10¢ 1847 stamp appears at auction once or twice a year; so if you don't like waiting, we suggest you pursue this example, with 2009 P.F. certificate. Scott \$12,500.

The Schermack Stamp Vending Machine Co. of Detroit Michigan was the only company to request the  $4\phi$  issue imperforate, and in May 1908, the company received 25 full sheets of four panes of 100 each (10,000 total stamps), all of which were made into coils with Type III perfs and given to the Winfield Printing Company. Winfield used about 60% on a mailing for Hamilton Carhartt and about 40% on a mailing for Burroughs Adding Machine Company. The imperforate  $4\phi$  would have a very limited use because  $4\phi$  did not pay a proper rate by itself.  $4\phi$  could pay the first class 2 oz rate (double weight), or the 4 lb second class periodical mailed by the publisher rate, or another seldom used third or fourth class rate.

Given that the samples were not flat, they often suffered from a rough pass through the machine, often causing tears or creases. They are rare today because a) they were not publicly issued, b) they were on third class commercial mail only, c) contemporary philatelists were not aware of their existence, and d) the physicians discarded most of the mailings.



#### 1918 "INVERTED IENNY"

The Inverted Jenny (Scott Catalogue #C3a) is one of the most famous and valuable error stamps in U.S. history. Here's an overview of its history:

#### Background

- Issued: May 1918
- Purpose: The first U.S. airmail service between Washington, D.C., Philadelphia, and New York.
- Stamp Design: A 24¢ airmail stamp depicting a Curtiss JN-4 "Jenny" biplane in blue ink at the center, framed by red ink.

#### The Error

- What Happened: During printing, one sheet of 100 stamps was mistakenly printed with the blue airplane vignette upside down inside the red frame.
- Cause: The printing process required two passes—one for the red border and one for the blue vignette. A single sheet was fed incorrectly.

#### **Discovery**

- Finder: William T. Robey, a 29-year-old bank clerk from Washington, D.C.
- Date: May 14, 1918, the very first day the stamps were issued.
- Purchase: Robey bought a full sheet of 100 for \$24 at his local post office.
- Aftermath: Realizing its rarity, Robey eventually sold the sheet to famed stamp dealer Eugene Klein, for \$15,000, a tidy \$14,976 profit!

#### **Dispersal**

- Notable Owner: Colonel Edward H. R. Green purchased the full sheet and later allowed Klein to number each position in pencil on the reverse before separating them.
- Eugene Klein broke the sheet into singles and blocks, selling them individually to collectors.

#### **Rarity and Value**

- Only one sheet of 100 is known to exist.
- Today, individual stamps from the sheet (depending on condition and centering) are worth hundreds of thousands to over a million dollars.
- The "Inverted Jenny" is one of the most iconic philatelic errors worldwide, often considered the "Holy Grail" of stamp collecting.

#### **Modern Notes**

KELLEHER AUCTIONS LLC

- The U.S. Postal Service reissued the design in 2013 as part of a souvenir sheet, deliberately reproducing the error for collectors.
- Some of the original 100 are lost, damaged, or locked away in institutions, but about 90 examples are accounted for today.

The release of the 24¢ Curtis Jenny stamp with the plane inverted is unquestionably the most iconic American stamp in existence. Its release is the philatelic equivalent of winning the lottery; the true story of a random individual purchasing the only known sheet at a post office window in 1918.

Even though other stamps with portions of the design inverted, such as the \$1 Candleholder (referred to as the "CIA invert") and the 29¢ New York Stock Exchange Bicentennial issue of 1922 with inverted center, found their way onto the market in an identical fashion and in either equal or lesser quantities (the quantity of NYSE inverts is roughly half the Inverted Jenny), the values for these newer stamps are completely eclipsed by the values of the Inverted Jenny. This is obviously so because of significantly higher demand.

The most iconic positions from the Inverted Jenny sheet are of course four of the remaining six blocks (plate, left corner with siderographer's initials, arrow, & centerline). The most iconic individual positions are position 1 with its selvage at left, the stamp offered here, and position 9, which Col. Green put into a locket gum side to gum side with a normal stamp as a gift for his then companion and future wife Mabel Harlow.
