#### The Artist

Jim Hautman was raised in a family of talented artists. Both of his parents and a brother are accomplished painters. Jim's interest in art, therefore, seems only natural.

"Art is something that I've always enjoyed," he says. "I don't remember when I started drawing, but I do know that my parents have always encouraged me in whatever I pursued."

Jim's father is also an avid outdoorsman who helped Jim develop a deep respect for wildlife. "My dad," Jim recalls, "loves to hunt and fish. Much of what I know about nature I learned from him. He instilled in me an appreciation and awareness for the outdoors."

## The Duck Stamp Artist - KEVIN T. DANIEL

• Collectors, sportsmen and wildlife lovers alike have been enthusiastic in their response to Kevin Daniel's artwork. His style conveys a romantic sense of discovery. • His work has been shown at the country's top wildlife art exhibitions including the Minnesota Wildlife Heritage Art Show, the National Wildlife Art Collector's Show and the Oklahoma Wildlife Festival. He won two "Best of Show" Awards at the National Wildlife Art Show in Kansas City and his painting "Consequence of Fire" won the "Best of Show" Award at the 1989 Minnesota Wildlife Heritage Foundation Art Show. • Unfortunately, serious health problems have plagued Daniel for much of his adult life. In fact, two years ago, he was nearly blind and facing kidney failure from diabetes. His eyes were so bad that he had to paint with a magnifying lens. Now, after two organ transplants, his eyesight is almost perfect and his motivation to paint has returned. The combination of medicine and strong determintation has given Daniel a new lease on life, and his artwork shows it. • Daniel was born and raised in Minneapolis, and has lived in Minnesota most of his life. He is a self-taught artist and has been painting and selling his art since age 14. He loves to do field research and can often be found, camera in hand, exploring the Minnesota river bottoms near his home in Chanhassen.
