# GENERAL REGULATIONS

The regulations listed below do not constitute all of the regulations.  
A hunting and fishing summary may be obtained at your license dealers.

## FISHING

Consult bait regulations for use of live bait.  
Bag and possession limits on trout, bass and channel catfish 10 each, except 25 channel cat may be taken from waters between Arizona and Nevada. The limit on striped bass in the Colorado River is 3 fish, minimum length 15 inches.

No bag limit on any other species.

No size or weight limit on any species except striped bass.

Valid license required:

A trout stamp validates Class A or B fishing license for the taking or transporting trout and is required for taking or attempting to take trout. To validate license, the trout stamp must be affixed on back of proper license. No trout stamp is required for Class D, E and F licenses.

General fishing license, a one day fishing license or combination hunting and fishing license required of anyone taking or transporting other species, except that a blind resident or any child under 14 may fish without a license and shall be entitled to the same privileges as the holder of a valid license, except that such person shall be entitled to only one-half the legal bag and possession limit on trout.

Nevada Special Use Stamp. In addition to regular fishing license required on waters between Arizona and Nevada, and California Special Use Stamp between Arizona and California. An Arizona license is all that is needed if fishing from the banks of Arizona.

Only one line or pole may be used, and not to exceed two hooks or artificial lures.

All fish possessed or transported must be kept with either heads or tails attached or in such a manner that species and number can be determined.

## HUNTING

When accompanied by a person holding a valid license a child under 14 may take small game, but not more than two such children shall accompany a person holding such a license.

Illegal to: shoot from, across or into a maintained highway or road; hunt or shoot from any vehicle; camp near a waterhole.

No shotgun larger than 10 gauge, nor capable of holding more than three shells, may be used for taking any wildlife in Arizona.

Consult your hunting regulations for information as to legal arms for taking big game.

Hunting on patented land is a privilege not a right. Respect the property rights of owners.
