Prior to the establishment of our Post Office Department letters were carried by independent mail routes.

One of the pioneer companies was the American Letter Mail Company; established in 1844 by Lysander Spooner. It consisted of a route from Boston to Philadelphia and way points. The original stamps were issued in black in sheets of 20, and sold to the public in full sheets. Therefore the wording on the enclosed specimens "20 For a Dollar" indicates that the postage for a letter

AMERICAN LETTERMAIL COMPANY

Mr. Lysander Spooner established this independent mail service in 1844. For one year the company delivered mail between Boston, New York and Philadelphia. But in 1845, the U.S. Government passed a law which put all private mail companies out of business. The stamps sold 20 for a dollar, or 5 cents each, which was the single letter rate. We can't offer the originals - they are worth over \$15.00 each, but you can add this set of five facsimiles (copies of the originals) to your collection for only a quarter. Please do not break this set.

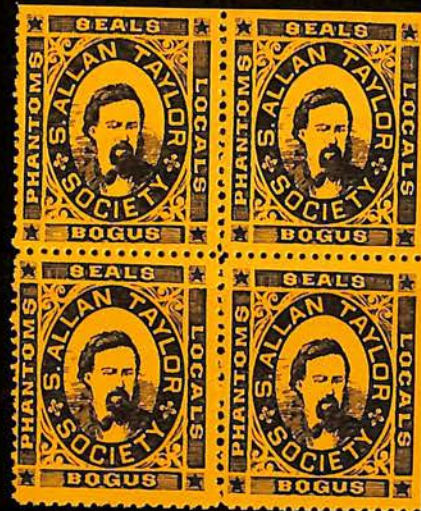
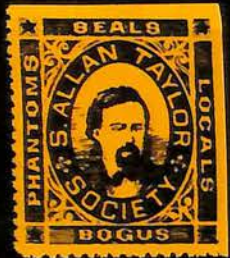

The "Army Franks", printed in rose, brown and blue, appeared in 1898.

Mr. W. Sellschopp in a paper read before the Pacific Philatelic Society (printed in "Filatelic Facts and Fallacies", Sept. 1898, Vol. VI., p 140) quotes letters from Army Headquarters and the Post Office repudiating the stamps.

UTAH

The Mormon stamp is one of the classic frauds. It is attributed to the year 1852 but was brought to the notice of stamp collectors in 1864 by a story in the "Standard Guide to Postage Stamp Collecting".



The article described an octagonal shape stamp with the head of Brigham Young thereon. It stated that Mr Young had issued an octagonal gold coin in 1852 and then issued a postage stamp of similar shape. Supposedly the stamp was intended for prepaying letters from one part of the Great Salt Lake Valley to another.

A letter from Brigham Young to H. S. Knight, dated June 18, 1864, states "To your reply, May 30, I have to reply that I have never issued, nor so much as thought of issuing a postage stamp."
