Atlantic, Auburndale, Braintree, Lower Falls, Newton, Newton Center, Newton Highlands, Newton Upper Falls, Newtonville, Quincy, South Braintree, Squantum, Waban, West Newton and Wollaston were all designated to become stations of Boston on July 1, 1908. However the Post Office Department under an order dated June 1, 1908, changed all stations to branches when located outside the city limits of the parent office, in this case Boston. This order was to take effect July 1, 1908. The above post offices on that date became branches not stations of Boston, however cancelling devices with station in the postmark had already been prepared and distributed. These cancels were used until replacements could be obtained and this varied from a few days to a few weeks. All are scarce.
